Specific academic activities under this MOU will be identified through consultation with the Department of Geography of the two colleges.

Each college agrees to provide their academic and technical assistance to carry out the specific activities which will improve the academic atmosphere, academic outputs, extension activities, academic quality, student's progression and research atmosphere in the respective departments.

1. General Terms of MOU

- A. Duration of MOU:** This MOU will be effective from the date of agreement and will have an initial duration of four years. There is also a provision to extend the MOU.
- B. Coordination:** In order to carry out and fulfil the aims of this agreement, each college will empower an appropriate faculty to coordinate the implementation of activities. The concerned faculties will meet regularly to discuss about plan, implementation and progression of the activities.
- C. Technical and Financial Support:** Technical & financial support of each activity will be provided by the college concerned.
- D. Confidentiality:** At any time, after executing the activities of this MOU each college agrees that none of the colleges will disclose any information in relation to these activities without consent of both colleges.
- E. Termination of MOU:** The partnership covered by this MOU shall be terminated upon the completion of the agreed period of four years. The agreement may also be terminated by a written one-month notice from both sides.
- F. Extension of Agreement:** The MOU may be extended according to the willingness of the both colleges with prior intimation and permission of the authorities, one month before the end of the MOU.
- G. Communications:** All notices, documents and any other communications under this agreement in connection herewith will be in written form and sent to the postal address, email, or fax of the college concerned. Any notice shall be effective from the date on which it is signed.
- H. Addendum:** Any Addendum to this MOU will be in written form and signed by authorities of both the colleges.
- I. Programme Consult:** All programmes will be taken up by the concerned department of the college with prior consultation with the corresponding department of the other college.


J. Venue of the Programme: Each college will organise any programme on their own premises in collaboration with other college by using their own assistance and resources. A third place may be treated as a venue of any programme but that must be done after a discussion and consultation of the two colleges with the financial sharing.

2. Other Provisions

- A.** Initially the department of Geography of the two colleges will facilitate the exchange programme. This type of exchange programme can be initiated by any other departments with due consultation of the authorities of the two colleges.
- B.** This type of exchange may be implemented in the field of cultural programme and sports activities too.
- C.** Students and teachers may visit and use departmental library as well as central library of both the colleges as and when required.
- D.** Students and teacher may use the resources of both the colleges during the exchange and extension activities.
- E.** Class teaching may be shared to the students (only to them who have proper ID card) with prior permission of the authorities along with proper Identity Card.
- F.** Faculty exchange for special lectures, seminar classes, workshops, field visits and other programmes will be made at departmental level with the consultation with the respective faculty and the departments concerned. Proposals for conducting National Level seminars and conferences will be given special importance from all the departments concerned in collaborative mode so that both the students as well as the institutions can benefit from the process.
- G.** Both parties assume that this agreement does not go against the rules and regulations of the Government of WB & UGC.


