### Memorandum of Understanding (MOU)

This MOU is made and entered into on the 15 December, 2022

#### Between

UDYAM–WB–11-0018300), Webel IT Park, Mangalbari, Dist.: Malda, P.O- Malda, West Bengal - 732101, India, represented by proprietor, namely Farid Rahman, s/o: Ziaur Rahman, aged 34 years, by faith Muslim, residing at Vill + P.O. – Gangaprasad, P.S. – Mothabari, Dist.- Malda, PIN: 732207, herein after shall be called as SECOND PARTY of this MOU.

#### Objectve(s):

This memorandum establishes a collaborative partnership between the First Party and the Second Party. It aims to facilitate joint programs related to workshop, training program and Conference/seminar. Additionally, the agreement seeks to promote collaborative activities as agreed upon pertaining to discussion and consensus from both the parties.

## General Terms and Conditions:

- 1. The agreement is effective from 15 December, 2022, for a period of five years.
- 2. Any modifications to the agreement require mutual approval and signing by both Parties.
- 3. Each Party may appoint a nodal officer to oversee collaborative activities.
- 4. Faculty Members/Trainers from both Parties can participate in the activities.
- 5. Collaborative activities will occur on the premises of each Party or at an agreed-upon third-party location.
- 6. Financial, technical, and academic support decisions must be mutually agreed upon. Both Parties can provide support for various initiatives.
- 7. There shall not remain any compulsion on any of the Parties to carry out programs.
- 8. The agreement will terminate after five years or upon written notice from both Parties.
- 9. Extension or renewal of the agreement is possible with mutual consent.

#### Time Frame:

This collaboration begins on 15 December, 2022, and lasts for five years. Termination occurs automatically after this period or by mutual agreement. Extension of the agreement is possible upon mutual consent.
